Please Read This Notice Before Completing The Enrolment Form.

This confidential enrolment form asks for personal information about your child as well as family members and others that provide care for your child. The main purpose for collecting this information is so that Crib Point Primary School can register your child and allocate staff and resources to provide for their educational and support needs. All staff at Crib Point Primary School and the Department of Education & Training are required by law to protect the information provided by this enrolment form.

Health information is asked for so that staff at Crib Point Primary School can properly care for your child. This includes information about any medical condition or disability your child may have, medication your child may rely on while at school, any known allergies and contact details of your child's doctor. Crib Point Primary School depends on you to provide all relevant health information because withholding some health information may put your child's health at risk.

Crib Point Primary School requires information about all parents, guardians or carers so that we can take account of family arrangements. Family Court Orders setting out any access restrictions and parenting plans should be made available to Crib Point Primary School. Please tell us as soon as possible about any changes to these arrangements. Please do not hesitate to contact the Principal, if you would like to discuss, in strict confidence, any matters relating to family arrangements.

EMERGENCY CONTACTS

These are people that Crib Point Primary School may need to contact in an emergency. Please ensure that the people named are aware that they have been nominated as emergency contacts and agree to their details being provided to Crib Point Primary School.

STUDENT BACKGROUND INFORMATION

This includes information about a person's country of birth, aboriginality, language spoken at home and parent occupation. This information is collected so that Crib Point Primary School receives appropriate resource allocations for their students. It is also used by the Department to plan for future educational needs in Victoria. Some information is sent to Commonwealth government agencies for monitoring, planning and resource allocation. All of this information is kept strictly confidential and the Department will not otherwise disclose the information to others without your consent or as required by law.

RELIGIOUS AFFILIATION

If you want your child to receive religious instruction while at Crib Point Primary School please complete this section. The Department of Education & Training needs to know what type of religious instruction is sought so the Department can, where possible, provide appropriate religious instruction at Crib Point Primary School.

IMMUNISATION STATUS

In most circumstances you can access your child's records. Please contact the Principal to arrange this. Sometimes access to certain information, such as information provided by someone else, may require a Freedom of Information request. We will advise you if this is required and tell you how you can do this.

If you have any concerns about the confidentiality of this information please contact the Principal. Crib Point Primary School can also provide you with more detailed information about privacy policies that govern the collection and use of information requested on this form. School profile statement

Crib Point Primary School is an eSmart school and recognises the need for students to be safe and responsible users of digital technologies. We believe that explicitly teaching students about safe and responsible online behaviours is essential, and is best taught in partnership with parents/guardians. Crib Point Primary School uses programs and procedures to support safe and responsible use of digital technologies. Our school actively carries out its duty of care for students working in online spaces by:

- having a Student Engagement Policy that clearly states our school's values and the expected standards of student behaviour, including actions and consequences for inappropriate behaviour

- never answer questions online that ask for my personal information
- only join a space online with my parent or teacher's guidance and permission
- not deliberately search for something rude or violent.

Care

When I use digital technologies I will:

- **look after myself and others** by thinking about what I share online
- protect my friends' information by thinking about what I share online
- protect my password and not share it with others
- use spaces or sites that are right for my age
- either turn off the screen or use the back button if I see something I don't like and tell a trusted adult.

Consideration

When I use digital technologies I will

- never share my friends' full names, birthdays, school names, addresses or phone numbers because this is their personal information
- stop to think about what I post or share online
- speak to a trusted adult if I see something that makes me feel upset or if I need help
- speak to a trusted adult if someone is unkind to me
- speak to a trusted adult if I know someone else is upset or scared.

Co-operation

When I use digital technologies I will

- never copy someone else's work or ideas from the internet and present them as my own. (I would include the link)
- be careful with the equipment I use.

Skilled office, sales and service staff:

- *Office* (secretary, personal assistant, desktop publishing operator, switchboard operator)
- *Sales* (company sales representative, auctioneer, insurance agent/assessor/loss adjuster, market researcher)
- *Service* (aged / disabled / refuge / child care worker, nanny, meter reader, parking inspector, postal worker, courier, travel agent, tour guide, flight attendant, fitness instructor, casino dealer/supervisor)

GROUP D Machine operators, hospitality staff, assistants, labourers and related workers
